



Privacy Notice for Longton Lane Primary School Pupils and Parents (How we use pupil information)

Why do we collect and use pupil information?

We collect and use pupil information under Article 6 of the General Data Protection Guidelines (May 2018):
6(1) (c) *'Processing is necessary for compliance with a legal obligation or*
6(1) (e) *for the performance of a task carried out in the public interest or in the exercise of official authority'*

We use the pupil data:

- to support pupil learning and protect pupil welfare
- to monitor and report on pupil progress and attainment through assessment
- to monitor and provide appropriate pastoral care including medical and behavioural needs
- to assess the quality of our services
- to comply with the law regarding data sharing
- to administer admissions waiting lists

The categories of pupil information that we collect, hold and share include:

- Contact details, contact preferences, date of birth, identification documents
- Results of internal assessments and externally set tests
- Pupil and curricular records
- Characteristics, such as ethnic background, eligibility for free school meals, or SEND
- Exclusion information
- Details of any medical conditions, including physical and mental health
- Attendance information
- Safeguarding information
- Details of any support received, including care packages, plans and support providers
- Photographs
- CCTV images captured in school
- We may also hold data about pupils that we have received from other organisations, including other schools, local authorities and the Department for Education.

Collecting pupil information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Storing pupil data

We hold pupil data for the following periods of time:

- Pupils' Educational Record: Duration of time in school. (Plus one academic year for Ofsted or diocesan inspections. This may include samples of pupils' books, case studies and analyses of assessment information)
- SEN records: DOB +25 years
- Child protection Records: DOB +25 years
- Accident record : DOB + 21 years

Who do we share pupil information with? We routinely share pupil information with:

- schools that the pupils attend after leaving us
- local authority officers
- Ofsted and Diocesan officers
- residential providers
- sports coach or other out of school club providers

- staff associated with school trips and competitions
- the Department for Education (DfE)
- social care personnel, where relevant
- school nurse service and other relevant health personnel
- third party parent communication providers e.g. Teacher to Parents texting services

Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring. Maintained schools are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

Data collection requirements:

The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013. The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data. For more information about the department's data sharing process, please visit:

Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact the School Business Manager, Mrs Kerry Lewis.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations

Complaints

We take any complaints about our collection and use of personal information very seriously.

If you think that our collection or use of personal information is unfair, misleading or inappropriate, or have any other concern about our data processing, please raise this with us in the first instance.
